Conditions and Notices:

1. The reenrollment fee is **SR2,000** per student and it is nonrefundable, but deductible from the tuition fees.
2. Enrollment reservation for current students will not be allowed unless all the previous fees are fully paid
3. Due date for reservation of place is **March 15, 2020**. It is mandatory for students to reenroll in order to maintain their places. The student will not be registered for next year if this form is not returned, along with reenrollment fees receipt by the set deadline. These may be given to your student's homeroom teacher.
4. Fees payment should be deposit to the National Commercial Bank (NCB) - International Bank Account Number (IBAN) **SA36 1000 0011 4876 6600 0703**. Or, by debit card at our admission's office. **We do not accept cash.**
5. Departing students must also notify the school by returning this form by the deadline. Departing students must inform the admissions office in writing at least **15 days** prior to the intended leaving date for the student's school reports to be prepared.
6. **Not replying and/or withdrawal after April 09, 2020 without notification shall incur an administration cost of 3,000 SR for the lack of confirmation and/or notification. This must be paid before receiving the student's file.**
7. New students, with siblings already enrolled on the school, will be given priority for admission based on the availability of vacancies.
8. A copy of this letter has been sent to your registered email and on the mobile application.
9. **Withdrawal of students after commencement of the first semester, 2020-2021, will result in the forfeit of the first semester tuition.**
